We write with regard to your recent enquiry for information held by the Council under the provisions of the Freedom of Information Act 2000.

Request and Response

Following the consultation on “Stratford Town Centre Improvements” which identified “introducing a 20 mph speed limit” as a “key improvement” and in the light of the 92% support from those responding to the consultation:

(a) What changes, if any, have been identified since the consultation and before the Cabinet meeting of 4 May 2017 to support the removal of a 20 mph limit from the scheme as agreed by the Cabinet;

All informal consultation results, local stakeholder feedback and engineering experience contribute to the final proposed scheme design that is put forward to Cabinet for approval. This means that a number of elements are considered or revised throughout the design process. In this instance the scheme has had no major physical changes after consultation, but consideration was given to the impact on traffic speeds and movements in surrounding residential roads if a strategic road was to

have lower speeds. This consideration informed the final proposal, however the response as part of the informal consultation and the need to ensure key improvements in traffic flows and safety, are why the scheme still retains the physical features that will naturally assist with safe traffic movements and speeds.

(b) Were any documents produced recording either the decision to omit the 20 mph limit from the scheme as presented in the Report to the Cabinet for its meeting of 4 May or recording the reasons for this;

No formal decision was taken to omit or include any scheme elements beyond the final scheme approval at Cabinet, therefore no other decision documentation exists.

(c) If so please, provide a copy of any record;

(d) Were there any discussions concerning the omission of the 20 mph speed limit at the Cabinet meeting of 4 May, or at Cabinet level at any other Cabinet meeting;
